Chris, Whitney and Julie read through the statements. There is room for improvement. NOTE: Sheba is not owned by HFH. Lawyer will be reviewing the lease agreement used for Sheba before any decision is made regarding reparations to the owner.

Small arena has a slight buzz which will be fixed Sunday. Electrician is working on finding new lighting for the tech room and new lighting for the arena. 8:13 PM	Treasury Report	Chris provided the report. Week away from payments. Paid \$1,370 on the farrier. Hay is next week, which is approx. \$2,040. Feed has been about \$600. Steve and Eric got 20 bags of senior feed from a company who donated them. Last feed bill was \$150. The truck insurance is cancelled and a truck was received for overpayment which was approx. \$460. HFH savings approx. \$21,200. The savings account is not a money market account. When Truist took over from the previous bank, we were required to call in to increase the rates. Rates have been increased to approx. 2% to 3%. If the rates go down again, we may want to consider switching banks. Checking account is approx. \$4,400. Eric asked if there's a possibility to move to a high-yield account. Gwen reviewed and some were asking for a minimum of \$20,000, however HFH currently cannot make this minimum monthly. Another thought would be to find a bank nationwide. This is the last week of camp, thus payments to instructors will go down.	Switching banks will be reconsidered at the beginning of the year.
